Artist shall be paid by school check within two weeks following completion of the engagement. This check shall be made payable to:

5. The Artist agrees to provide all necessary equipment for the performance. All the Artist's equipment must be removed from said area within 45 minutes after completion of the performance. Failure to comply will result in the renegotiation of the contracted price on the next working day.

6. The Presentor shall at all times have complete supervision, direction and control over the services of Artists at the engagement. These shall include supervision of set-up, equipment placement, electrical outlet usage, volume of music and whatever Presentor deems necessary.

7. If the Artist(s) is not ready for the commencement of the program at the starting time stated above, payment will be withheld until the contract is re-negotiated on the next working day. All set up must be done before the starting time.

8. The Presentor will not supply any food or beverages for the Artist(s), unless previously negotiated.

9. The Artist(s) and all individuals assisting must be 18 years of age or older. Proof of age must be presented upon request of the management.

10. The Artist(s) understand that their performance is not public. All advertising must be approved by Presentor.

11. The Artist(s) understand that there will be no stage crew or staff available to assist the group in setting up or breaking down, unless previously negotiated.

12. The Presentor is not responsible to provide any equipment or liable for any damage to the Artist(s) equipment. In addition, the Artist(s) will be liable for all damages to the Presentor's equipment due to the Artist(s) negligence or misuse.

13. If this contract is signed by anyone other than the Artist(s), the person signing for the Artist(s) expressly warrants that he is authorized by the Artist(s) to execute this contract on behalf of the Artist(s) for this engagement for the time and place specified in this contract.

14. This contract shall be construed and governed in all respects according to the laws of New York State unless otherwise agreed to in writing by both parties or stipulates in this contract.

15. The Representative of the Presentor, in signing this contract warrants that he/she signs as a properly authorized representative of L.I.U./C.W. Post Campus and does not assume any personal liability for meeting the terms of this contract.

16. The Presentor is hereby relieved of any liability if unable to meet the responsibilities of this contract due to any act of God, riots, epidemics, strikes, any act or order of public authority, or any other legitimate cause beyond the control of the Presentor. If such acts or conditions occur, the Presentor is not liable for any damage which the Artist, his/her group or representative might suffer.

17. The Artist(s) understands and agrees that the Artist's failure to fulfill any of the provisions of this contract, without prior consent of the Presentor, will be considered a material breach of contract and my result in the cancellation of the engagement hereunder at any time without liability whatsoever to the Presentor. Furthermore, if the Artist(s) breaches this agreement, which the Presentor has entered into in good faith, all damages that are suffered by the Presentor will become the Artist(s) liability.
