## Brentwood Campus, Long Island University Undergraduate Waiver of Admissions Credentials

Undergraduate applicants are required to submit one **OFFICIAL TRANSCRIPT** from each institution of higher education previously attended. This process can sometimes take an extended period of time and can delay the applicants' ability to register for courses. In order to speed up this process, the Office of Admissions offers this Waiver of Admissions Credentials Form. This form can be submitted in place of **OFFICIAL TRANSCRIPTS**, and will allow applicants to register immediately under a Non-Matriculated status while these transcripts are being assembled. Once all required transcripts are on file, a Full Matriculation can be granted.

Please note the following:

- ∞ The form may be submitted at any time, but will only be processed when followed by a **PHOTOCOPY** of the applicant's transcripts.
- ∞ An appropriate GPA must be demonstrated on the transcripts.
- ∞ Financial Aid and/or scholarships cannot be processed until all requirements have been satisfied. Awards are dispersed on a "funds-available" basis. It is therefore to your advantage to complete your admissions file as quickly as possible.
