IMPORTANT VISA INFORMATION

COMPARATIVE RELIGION AND CULTURE PROGRAM

TAIWAN

VISA TYPE: NOT REQUIRED (for a maximum stay of 90 days).

US citizens are not required to obtain a visa for entry to Taiwan, for a stay up to 90 days.

All travelers will need a passport valid for <u>at least 6 months</u> following your departure date from Taiwan. You will also need to present your onward air ticket (to Thailand) and your Thai visa.

Most destinations, including Taiwan, require that you have adequate un-used pages in your passport, allowing for any necessary stamps upon arrival and departure. We recommend that you have at least two free pages in Visas section of your passport before any international travel. U.S. citizens can get extra passport pages added to their passports as fast as within 24 hours.

THAILAND

VISA TYPE: TOURIST VISA (valid for a maximum of 60 days).

The visa must be utilized within 3 months of issue, so please apply for this visa around the second week of August, as the Thailand term does not begin until the end of October/early November.

You will need:

Processing fees \$40 USD (One entry – required), \$80 USD (Two entries – optional)
Copy of Airline Itinerary

TURKEY TERM

American citizens traveling to Turkey on U.S. passports must obtain a visa upon arrival in the country. Currently, holders of all types of passports can purchase a 90-day sticker visa at the port of entry for \$20 cash if they are traveling to Turkey as tourists. There is an ATM machine in the airport that you can use to withdraw the money needed when you arrive in Turkey, or you can change money prior to your departure from India.
