Room and Meal Plan Cancellation Policy

The \$300 housing deposit is non-refundable after August 15th for the Fall semester and January 1st for the Spring semester. Once a student has signed a housing contract said contract is for the entire academic year. This agreement may be canceled in writing by notifying the Residence Life and Housing. The student will be subject to charges as indicated in the liability schedule below. These charges apply to all students including those who cancel due to leave of absence or withdrawal.

Cancellations after taking occupancy for any reason (graduation, withdrawal, and leave of absence) must be made in writing. The effective date of a student's cancellation is the date on which the student: cancels in writing, vacates and removes all personal belongings from the room, and properly checks out with the Brooklyn's Residence Life Staff. The cancellation will not be considered effective until all three conditions are met. Cancellation/termination of agreement submitted after occupancy is eligible for refund according to the refund schedule below:

Room & Meal Plan Liability Schedule: Fall, Spring, & Summer

- Pro-rated based on number of days occupying the room and/or board plan (rate/total days in a term)
- After week 6 of each Fall and Spring semester, student is 100% liable for all room and board charges
- After week 3 of each Summer session, student is 100% liable for all room and board charges.
