Please remember that, whichever you choose, you will need to present your original unexpired government issued photo ID:

- Such as, but not limited to, a driver's license, non-driver's identification card, other state-issued ID, or a signed U.S. passport.
- We may not accept an ID issued by a state university/college or a military ID that is prohibited from being copied as we must retain a copy as part of the verification process
- Your full name on the ID you present must match the name on your FAFSA and your name on record with Long Island University
