

SERVICES AVAILABLE

It is the mission of the DSS office to ensure that students with disabilities have equal access to all aspects of university life. Reasonable accommodations are determined on a case-by-case basis according to documented need and are coordinated primarily between the student and the individual faculty member. Typical accommodations may include extended time for testing, separate location for testing, readers and/or scribes for exams, note takers, digital audiobooks and/or alternate format, sign language interpreters for the deaf or hard of hearing or CART services and assistive technology. Accessible classrooms and residence hall facilities can be arranged when necessary.

The DSS office is committed to providing assistance and advocacy to students with disabilities as well as education for the campus community.

DISABILITY SUPPORT SERVICES

The Office of Disability Support Services (DSS) assists students with disabilities to ensure equal access to all programs, services and facilities at the LIU Post campus and the university's regional campuses. The Learning Support Center, of which DSS is a part, provides free assistance to students that is consistent with Section 504 of the Rehabilitation Act and the Americans with Disabilities Act. It is the collaboration among the student with a disability, the faculty/staff member and the DSS office that best contributes to student success.

WHO IS ELIGIBLE FOR SERVICES?

Under federal and state laws, a person with a disability is someone who has an impairment that substantially limits one or more major life activities. Such disabilities include, but are not limited to, physical, learning, psychological, social, medical and sensory, as well as temporary impairments.

PROCEDURE FOR RECEIVING ACCOMMODATIONS

Accommodations are determined on a case-by-case basis, taking into account the needs of the student and the course standards. The determination of an appropriate and reasonable accommodation is based on approved documentation and through interaction with the student.

■ Documentation:

A student with a disability who desires accommodations must submit a Request for Accommodations form together with appropriate documentation of his or her disability to the DSS office. In most cases, appropriate documentation should be no older than three years and must include a diagnosis of a disability, the testing and

results that explain the nature of the disability, the way it currently impacts the student academically or otherwise, and suggestions of accommodations that might work for the student.

■ Evaluation of Documentation:

Appropriate professional staff in the DSS office will review and evaluate the disability documentation that a student submits. Confidential files will be established for documented students with disabilities.

■ **Meeting with the DSS office:** After the documentation has been reviewed, appropriate professional staff will meet with the student and provide the appropriate DSS Accommodations Forms for the student to present to professors. If needed, the DSS office will notify the campus departments of special accommodations.

■ Accommodations:

Each academic department will provide the accommodations needed by the student. These academic accommodations may include, but are not limited to, extended time for tests, note takers, recording class lectures, reader and/or scribe for tests, and the use of a computer for an essay exam. It is the policy of LIU Post to have faculty provide test accommodations within their department. Other campus departments will be responsible for making accommodations as necessary.

We strongly encourage students to contact the DSS office well in advance so that appropriate accommodations can be arranged.
